

Our Privacy Policy

“Personal information” is information we hold which is identifiable as being about you. Personal information collected by us will only be used in accordance with this Privacy Policy and the Australian Privacy Principles.

1. What personal information we collect

Membership details collected upon joining Rhee Tae Kwon-Do (Victoria) or signing up for access to our website may include:

- names;
- date of birth;
- occupation;
- contact information including addresses, email addresses, phone numbers, fax numbers etc;
- demographic information;
- any previous history of Tae Kwon Do training.
- past and present grading information
- other information relevant to the customisation of a document on our website;
- communication between us;

2. Non-personally identifiable information

For each visitor to our website, we collect the following non-personally identifiable information, including but not limited to pages viewed while browsing the site, browser and operating systems, page access times and referring website address. This collected information is used solely internally for the purpose of gauging visitor traffic, trends and delivering personalized content to you while you are at the site.

3. How we collect your personal information

We collect personal information from you in a variety of ways, including: when you interact with us electronically or in person; upon completion of membership or grading forms; and when you access our website as a signed in member.

4. Use of your personal information

The transmission and exchange of information is carried out at your own risk. We take steps to safeguard against unauthorised disclosures of information, however we cannot assure you that personal information will not be disclosed in a manner that is inconsistent with this Privacy Policy.

9. Accessing your personal information

You have a right to access your personal information in accordance with the provisions of the Privacy Act 1988.
